## **BACKGROUND**

- A regional debriefing policy was first developed at the 6th Pacific Island Regional Fisheries Observer Coordinators' Workshop (ROCW6) held in Honiara in January 2006.
- The revised PIRFO Debriefing Policy was endorsed by the first Debriefing Workshop in Cairns, July 2010
- A PIRFO Debriefing Strategy Workshop was held at SPC headquarters in Noumea, New Caledonia from 28<sup>th</sup> February -18<sup>th</sup> March 2011:
  - to review the regional observer programmes with focus on the debriefing component;
  - to develop a debriefing training and assessment strategy, and certify RCC at least one experienced Debriefer from eight of the countries attending;
  - to develop regionally coordinated national debriefing implementation strategies to continue to certify Debriefers.
- FFC77 (2011) endorsed development of accreditation standards for debriefers and trainers
- FFC81 (2012) endorsed continued development of competencies for debriefers, trainers and the initiation of competencies for assessors

#### WHY DEBRIEF?



#### to:

- quickly <u>report</u>, and action if necessary, critical incidents that took place on the trip;
- Data <u>quality assurance</u>
- flag data that does not meet the specific <u>quality</u> requirements of data users;
- give Observer Coordinators feedback on their observers' <u>performance</u>;
- give observers timely direct <u>feedback</u> on how they can improve their data;
- explore, through questioning, if <u>additional information</u> can be gathered about the trip;
- judge if the quality of the data has suffered through <u>harassment</u> of the observer;
- <u>assess the skills</u> and experience for pay and promotion purposes;
- verify data before <u>distributing</u> them to other agencies ( FFA PNA, SPC, SPREP AND WCPFC.;
- find out if special consideration is necessary for <u>future placements</u> on that or like vessels


#### PURPOSE OF DEBRIEFING POLICY



- Provide principles of debriefing
- A guide to the processes and rules for debriefing
- Identify training standards
- Set protocols for transparency, fairness, consistency, timeliness.
- Provide an INDEPENDENT mechanism of oversight and audit of debriefing to guarantee the data to third parties (CMC).
- NOT Standard Operating Procedures that's in the guide




#### TRANSPARENCY IN PROCESS






#### FAIRNESS IN EVALUATIONS





#### **CONSISTENCY IN PROCESS**


#### Debreifer Evaluations Given 2018





#### TIMELINESS - ACTUAL DEBRIEFING WAITING TIME


TDW (2014) programme agreement for 14 (PS) -21 (LL) days time limit to initiate debriefing

#### **DEVELOPMENTS**

- Now have +150 debriefers, including +60 Debriefer Mentors and Assessors, (800+ Obs.)
- New PIRFO Framework revised for Observers Debriefers needs upgrade
- Development of PIRFO Debriefer Mentor and Assessor standards and delivery
- EQAP recognition of PIRFO Observer, Debriefer, Debriefer Mentor and Assessor
- EM Verification (Debriefing), how to do it, who can do it????



#### DEBRIEFER MENTOR AND ASSESSOR

The development of the micro-qualification PIRFO Debriefer Mentor and Assessor was finalised at a workshop held in Brisbane 24th & 25th June 2019

#### Prerequisites?

- Currently accredited as a PIRFO Debriefer
- Demonstrated transparency, consistency, fairness and efficiency in Debriefing evaluations of observers

#### **Delivery?**

Delivery conducted by at least one suitably qualified PIRFO Trainer and Assessor for every 8 learners.
 The practical component, delivered in the workplace or a simulated environment, should be a one to one ratio.


# EM REVIEWERS (VERIFICATION)



- Essentially this quality assurance assessment can be separated into two processes:
  Verification and Validation
- **EM Verification**: A process of evaluating the completeness and compliance of a collected data set against the required data fields, format, protocols and normal range of expected results.
  - Completeness of data fields and formats
  - Critical Incident assessment
  - Truth of unusual events
  - Technique of established protocols followed
  - Logic pathways, and
  - A second expert reader
