# Session 8.2 Licensing Reports

# **INTRODUCTION**

TUFMAN offers users a number of pre-formatted reports to help them account for the data that has been entered into the database. These reports are all accessed from the 'Reports' button on the main TUFMAN menu.


Reports can be produced in two different formats.

- A nicely formatted PDF version, which can be used directly in written reports and;
- An Excel format which can be used to further manipulate the report layout or data

# Things to know before you start

# Run post entry processing - the first step in reporting


To ensure that the data is up-to-date and fully linked (see XX) you are advised to always run processing before you produce any reports. The run processing can take a while, especially if new data has been running, so leave time to do this. Luckily TUFMAN is set up in a way that should remind users with at the top of the reports sub-menu.



# **Reports Sub-menu**

# **Reporting Data Parameters**

Select the range of data you want to report on. For instance; which gear type, fleet, dates and fishing area. For some reports you will also be asked to choose the fishing company or vessel name. TUMFAN will highlight the data ranges (or reporting parameters) that must be filled in.



#### Notes on the data parameters

#### TIME – Group by

When Year is selected TUFMAN will report the data for the whole year When 'Month' is selected TUFMAN will report the data for every month When Quarter is selected TUFMAN will report the data for every quarter (i.e. January – March etc)

#### **AREA**

When EEZ Area is selected TUFMAN will report the data for the home EEZ only Sub Area Breakdown is selected TUFMAN will report the data for specific areas. This is not relevant for most countries but Kiribati uses it for its three main island areas. EEZ Breakdown is selected TUFMAN will report the data for every EEZ that the vessel was fishing in.

If an Agreement is active at any point during the selected year, it will be selected in this report, regardless of whether it was (i) inactive at the start of the calendar year, or (ii) inactive at the end of the calendar year. All Agreement and all licence information must be entered to get a complete "List of

Agreements report". The 'Agreement details form' and the 'Licence details form' must be fully filled

in.

refer to when you are preparing internal work report or more general reports like your National

Fishery Status Report for SC. It is also a useful report when preparing 'Access Negotiation Briefs'. By

changing the year of this report you can prepare historical Agreement information, and summary

(but not detailed) historical licensing information.

- 3a This report gives summary licence information for each Agreement, for the selected year, in company/ association alphabetical order. The vessel name, the licence number and the status of the licence including the start and end date as well as the issue date are all displayed in this report. You can select a specific company / association by using the reporting parameters.
- 3b This report gives summary licence information for each fishing company, for the selected year, in company / association alphabetical order. Alternatively, you can choose this report over a number of years, and / or for a specific fishing company by inputting the required parameters at the end of the page. The vessel name, the licence number and the start and end date as well as the type of licence issued are all displayed in this report.
- 3c This report gives a list of the licensed vessels for the selected year ordered by the gear and then by the vessel's nationality, for the selected year.

#### Things you should know and check for before using this report.

- 3a -An Agreement may appear more than once during a calendar year. If for example an Agreement terminates during the selected year and then another new Agreement starts immediately after. If an Agreement is active at any point during the selected year, it will be selected in this report, regardless of whether it was (i) inactive at the start of the calendar year, or (ii) inactive at the end of the calendar year.
- 3b A licence may appear more than once during a calendar year. If for example a licence terminates during the selected year and then another new licence starts immediately after. If a licence is active at any point during the selected year, it will be selected in this report, regardless of whether it was (i) inactive at the start of the calendar year, or (ii) inactive at the end of the calendar year.
- 3c If a licence is active at any point during the selected calendar year, it will be shown in this report. Regardless of whether it was (i) inactive at the start of the calendar year, or (ii) inactive at the end of the calendar year.

#### What is this report useful for?

3a -This report will be used as an internal administrative report to give information about licences issued under one or all Agreements. This report can be used to check that any limit put on the number of licences, as set by the Agreement, has been adhered to. The report can be referred to when preparing Access Negotiation Briefs, as it may be set to show how many vessels were licensed under the Agreement in the past. This report may also prove useful if sent to the company / association if they require an up-dated list of all the vessels that have licences for the chosen year. The individual company / association should be selected in the reporting parameters.

<sup>\*\*</sup>This report is a useful data quality check for licencing data entry.

- 3b This report is useful internal administrative report when preparing other reports i.e. quarterly work reports or Access Negotiation Briefs for instance. It may be useful to prepare this report for a particular company/ fishing association. In that case the company / association can be selected in the reporting parameters.
- \*\*This report is a useful data quality check for licensing data entry.
- 3c The report will be produced when information is required about licences for each gear type. Normally this type of information will be required for internal administration reports, or for reports describing the fishery (i.e. ad-hoc requests from consultants.)

#### **Report Description**

4a - This report gives comprehensive information on vessels that are currently licensed for each company / association in alphabetical order. It is date-stamped at the top of the report, so the report is only valid on the day it is produced. The report details the type of licence, the vessel name the FFA vessel identification number, the licence number and the status of the licence (you can see if the vessel licence has been suspended, cancelled or re-instated at any point during the report dates), the licencing dates and all the fees related with each licence.

4b - This report gives a complete list of all vessels that are licensed to fish. It is only valid on the day it is produced. The report is ordered by Call-Sign, as this compulsory vessel marking is easily seen by government officials even if they are far away from the vessel.

# What can this report be used for

4a - This report is useful for verifying the list of current licences that are licensed to a specific company on the day. It may be helpful if there are any requests on licensing from the fishing company, or if a compliance officer is going to visit a company and requires current licencing

information. This report can also be used to check for licensing data entry and should be produced periodically.

4b- This report is best used by monitoring and compliance personnel during times of national and/or sub-regional surveillance operations. Your compliance department may request this information before or during their surveillance trips. This report will be requested by FFA on a regular basis.




