For example, (i) specific improvements in systems, (ii) any new stumbling blocks, (iii) changes to resources for data collection/management, (iv) introduction of special legal provision of data which has had an effect, etc..
- What is the progress with the NATIONAL PROCEDURES documents?

MAIN OUTCOMES: Synthesis of a list of common points from national reports and presentations, perhaps highlighting the main areas for attention. Discussion may provide some ideas on how to resolve any problems. A revised responsibility matrix for each country.

AGENDA ITEM 3 SOME CURRENT ISSUES IN DATA COLLECTION AND MANAGEMENT

This year, the workshop will review several issues in data collection and management that have some importance in the region. There will be a brief presentation introducing each topic/issue, then discussion in plenary. Where relevant, group exercise sessions may be arranged following plenary discussion.

Agenda Item 3.1 Artisanal Tuna Fisheries Data Collection

Participants will be asked to complete a basic questionnaire regarding their artisanal tuna fisheries, prior to the workshop. The presentation and discussion will review issues such as,

- Why collecting artisanal tuna fisheries data is important
- What Artisanal tuna fisheries exist throughout the region ? (review of survey)
- Distinction between artisanal fisheries for tuna and other species
- How artisanal data will be used?

Agenda Item 3.2 Ramifications of increased Observer activity

The presentation and discussion will review issues such as,

- Background on the reasons for increased observer activity
- How this will effect data collection at the national and regional level
- How this will effect data management systems at the national and regional level
- What member countries need to do ...

Agenda Item 3.3 Data gaps listed by the WCPFC

The presentation and discussion will review issues such as,

- Brief review of obligations for providing data to the WCPFC
- Explanation of the requirement for providing historical data to the WCPFC (e.g. providing data for your own fleet and for foreign fleets)
- Review of data gaps in each country (exercise)
- Procedures for follow-up

Each country will be provided with a table showing their provisions of data to the WCPFC prior to the meeting and will be asked to cross-check with their understanding of what has, or has not, been provided.

- Background on the reasons for increased observer activity in the future
- How this will effect data collection at the national and regional level
- How this will effect data management systems at the national and regional level
- Difference in data provision compliance between foreign and domestic fleets

MAIN OUTCOMES: Participants will be better informed of these issues which may help them deal with any needs or problems as they arise in their country.

AGENDA ITEM 5 PREPARATION OF ANNUAL TUNA CATCH ESTIMATES

A presentation in plenary will cover the following items:

- An abridged version of the TDW-2 presentation on the methods for annual catch estimates
- Review of the timeliness of provision of 2007 estimates before 30 April 2008
- Provision of new template to fill in this year's annual catch estimates
- Questions that each country will expect to be asked ...
 - o What is progress with 2008 estimates?
 - o When will estimates be provided?
 - o What methodology?
 - o Any improvements in coverage or methods used?
 - o Any problems?

[A full presentation and exercises that were provided in TDW-2 can be provided on Wed PM for new participants, if required]

INDIVIDUAL EXERCISE: (undertaken during the week) Each participant will be asked to determine catch estimates for 2008 (and review/update of estimates for the four years prior to 2008) using the information they have from their fishery. (Participants have been asked to bring their TUFMAN, or other Tuna fishery databases, and any other summarised data/information that will be used in the exercise to estimate annual catches).

MAIN OUTCOMES: Participants will be familiar with the importance of coverage and some of the methods used for determining annual catch estimates.

The successful completion of this EXERCISE will entail each country producing at least a provisional estimate for their national fleet, or a provisional estimate for the catch of a foreign fleet fishing in their waters (for countries that don't have a national fleet), in addition to an explanation of the coverage and type of data used, and the method used to estimate the catch.

- PROBLEMS in getting the data

SPC Staff will be on hand to assist participants.

MAIN OUTCOMES: Participants will have developed a clear plan for producing the data summaries for inclusion in their SC National Fisheries Reports.

Thursday/Friday 23-24 April 2009

AGENDA ITEM 7 AN INTRODUCTION TO AUDITING

Presentation revisiting the concepts of auditing and a description of two draft WORKBOOKS for auditing (PORT SAMPING and LOGSHEETS). What is "Self-auditing" and the importance of having independent experts conducting the auditing.

EXERCISE: Participants will be asked to do a preliminary self-audit of their own data collection/management systems using the draft WORKBOOKS.

EXERCISE: If there is time available, 2-3 groups of participants will conduct an audit of a "simulated" port sampling data collection programme using the AUDIT WORKBOOK. The results will be reviewed in plenary. (Each group will have 30 minutes to observe and interview staff in the simulated port sampling collection programme, and complete their audit – usually audits will take longer, but this exercise aims at introducing participants to concepts of auditing).
